### Overview

This policy supports medical necessity review for the following Topical Antiviral Products:

- **acyclovir** 5% cream
- **acyclovir** 5% ointment
- **Denavir**<sup>®</sup> (penciclovir) 1% cream
- **Xerese**<sup>®</sup> (acyclovir and hydrocortisone) 5%-1% cream
- **Zovirax**<sup>®</sup> (acyclovir) 5% cream and ointment

Receipt of sample product does not satisfy any criteria requirements for coverage.

### Medical Necessity Criteria

**Coverage varies across plans and requires the use of preferred products. Refer to the customer's benefit plan document for coverage details.**

The products in the table below are considered medically necessary when the following are met:

When coverage is available and medically necessary, the dosage, frequency, duration of therapy, and site of care should be reasonable, clinically appropriate, and supported by evidence-based literature and adjusted based upon severity, alternative available treatments, and previous response to therapy.

## Reauthorization Criteria

Topical Antiviral Products are considered medically necessary for continued use when initial criteria are met AND there is documentation of beneficial response.

## Authorization Duration

Initial approval duration is up to 12 months.  
Reauthorization approval duration is up to 12 months.

## Conditions Not Covered

Any other use of topical antiviral agents is considered experimental, investigational or unproven, including the following (this list may not be all inclusive):

- Shingles (Herpes Zoster)

## Background

### OVERVIEW

#### Professional Societies/Organizations

National guidelines published by the CDC report that the topical antiviral agents offer minimal clinical benefit for genital herpes infections and should not be recommended over the oral antiviral agents (acyclovir, famciclovir, and valacyclovir).<sup>6</sup>

Shingles is a viral infection caused by the varicella zoster virus, the same virus that causes chickenpox.<sup>3</sup> The Centers for Disease Control and Prevention cite the use of oral antivirals (acyclovir capsules/tablets/suspension, famciclovir tablets, and valacyclovir caplets) for the treatment of shingles. Oral antivirals speed healing and reduce the risk of complications. Topical antivirals are not noted as treatment options for shingles.
